



Partnership Agreement

Central Indiana Educational Service Center provides supplemental online courses to high school students through Indiana Online in partnership with schools across the state. The following points clarify the mission of the Indiana Online program in providing an alternate option of quality instruction for high school students while allowing Indiana school districts to retain their students.

- Students who take courses with Indiana Online are retained as students from their home school, enabling the school to keep the ADM for that student.
- Courses are developed and taught by highly qualified Indiana licensed teachers. The content of each course meets the Indiana State Standards for each subject area and is equal to one high school credit.
- Indiana Online provides courses for scheduling challenges, advanced placement, and homebound students on a monthly enrollment basis throughout the year.
- Indiana Online provides a cost-effective Summer School option. The flexible schedule works great for students traveling and participating in band or athletic camps.
- The student completes the online registration. Notification is e-mailed directly to the enrollee's designated Guidance Counselor for approval before enrollment occurs.
- The course teacher guides the student through the course with frequent personal contact by Virtual Classroom, telephone, text, and/or e-mail communication.
- Final Exams are computer based and available upon completion of the student's course work.
- Final grades are emailed directly to the student, parent, and the designated Guidance Counselor.
- The district will communicate with CIESC the payment arrangements with regard to who is responsible for the expense of the course. For the student's convenience, a credit card payment option is available, as well as the option to make a payment by mailing a check.
 - The CIESC member school tuition is \$250.00 per enrollment. The Non-CIESC member school* tuition is \$275.00 per enrollment.
 - Bulk pricing discounts are available. Please refer to our Tiered Enrollment Pricing Document for more information.
- This Agreement shall be valid for three full school years. If signed within a school year, this agreement will be valid for that remaining school year and the two school years immediately following. Separate Summer School agreements will be signed before every summer session.

* Application for CIESC membership is available for school corporations located in the Indianapolis area and areas which have a shared border with and existing CIESC district member. A one-time entry fee plus annual membership fee (based on a district's enrollment) will be charged upon approval for membership. Tier Enrollment Pricing

School Districts or High Schools may purchase tiers of student enrollments. The following fee structure will apply based on student enrollment over a period of one academic school year (August-May). **This excludes summer school enrollment**. A District/High School may also purchase a tier enrollment for a specific course/courses. A current signed Partnership Agreement must be on file with Indiana Online to sign up for Tier Pricing. Schools will be charged for at least the minimum number of enrollments in the agreed-upon tier. All students enrolled from the district will receive the tier price. Enrollments paid by the student will not count toward tier level enrollments numbers. Tier Pricing will take effect only after a Memorandum of Understanding for the current school year has been received. Enrollment is defined as one credit, or one semester of a course, per student.

Technology training will be available for schools using an Instructional Assistant for an Indiana Online Course and will be provided at no additional charge. Indiana Online offers flexible enrollment including six different sessions per school year.

The District/High School will be invoiced for the minimum enrollment of the tier chosen 30 days subsequent to the completion of the Tiered Enrollment Memorandum of Understanding. The District/High School will be billed for the remaining enrollments over the minimum tier in April of that school year. (Example: When a Non-CIESC Member District/School signs the MOU for Tier 2, Indiana Online will invoice them for 25 enrollments (\$250 each) within 30 days. If the District/School has 30 total enrollments by April, Indiana Online will invoice for the additional 5 enrollments.)



Please provide a list of the Guidance Counselors and their e-mail addresses; as well as where to send an invoice and to whom. The Counselor's names are listed on the registration site for the students to select their specific counselor. The system will then e-mail the counselor requesting approval as well as providing access to the student's progress, grades, final exam information and transcripts.
